Quick Reference of Rules

- Tournament is set up to have fun!
- No fighting or cursing, this will cause IMMEDIATE team ejection from tournament.
- First team to 21 points wins. There will be a 25 minute time limit on each game.
- At the end of the time limit, the team with the most points wins.
- After team scores, the possession of ball will change. (NO "Make it, take it.")
- Each team shall have a limit of five (5) players, with no other substitutions.
- Each team must always have three players playing. (No substitutions of a fifth player.)
- 1 free throw will be awarded for each foul after the 8th team foul.
- Scorekeeper will keep official time and score.
- No dunking allowed. This will cause loss of the game.
- No grace period allowed. Team will forfeit if not present at start time.
- Tournament guarantees 4 games (depending on amount of teams, prior to bracket play for top 4 teams.)
- T-Shirts will be awarded to the Champions of each division.

Waiver and Release
